1. The camp is aimed at children aged 9 to 14 years
2. All children must have sun protection (hat, sun screen lotion etc.), water bottle, and appropriate clothing for football activities.
3. Children are expected to behave in an appropriate manner. If your child misbehaves or acts in a manner that disrupts the rest of the group, they will be verbally warned by the Club staff. If the child continues this behavior, this may result in the child being excluded from the Camp for the day, or if appropriate for the rest of the camp, without refund.
4. Although best possible care will be taken, the Club cannot be liable for the loss, theft or destruction of any personal belongings
5. All Children enrolled in the Camp will participate in activities with other children, subject to collective supervision in a variety of games and training exercises. I hereby waive and release Club and its owner, successors and assigns, from any liability, claims, costs, expenses (including legal fees), damages, which the child or myself or other persons may have against the Club as a result any injury, loss or damage which the child may suffer or incur while participating in such program, or as a result of any decision taken under the authorization granted herein.
